As to the Disney PhotoPass photos and video digital files purchased by or otherwise made available to you for authorized download on [www.disneyphotopass.eu](http://www.disneyphotopass.eu) ("Digital Media Files"): a worldwide, perpetual, royalty-free, limited license solely for personal, non-commercial use to (i) create or have created by a third party, photographic prints and photographic products wherein an image is incorporated into a product (e.g. mug, calendar, photo book, mouse pad, t-shirt, magnet, ornament, cards, tote bag, etc.) ("Photo Products"), (ii) post the Digital Media Files on Licensee's personal social media accounts, (iii) display the Digital Media Files on Licensee's personal computer, mobile device, or television and (iv) otherwise use the Digital Media Files for other similar personal, non-public, non-commercial purposes.
